Reporting to the Director of the Barrett Centre for Crisis Support, the Mobile Community-Based Rapid Access Addictions Medicine (RAAM) Nurse Practitioner (MCBR NP) enhances the dignity and quality of life of our patients by providing immediate and low barrier access to addictions medicine, with a focus on vulnerable populations facing multiple, complex barriers to accessing treatment. The MCBR NP works out of clinics at various community agencies and should effectively navigate and build community partnerships.

All services provided will be directed toward improving quality of life, restoring health, reducing harm and promoting recovery and within the scope of practice as per *Regulated Health Professions Act*.
